YOU MAY BE FLUSHING AWAY OVER 30 PERCENT OF THE WATER THAT'S USED INSIDE YOUR HOME. IN FACT, A HOUSEHOLD OF FOUR PEOPLE WITH A STANDARD TOILET (USES 3.5 GALLONS PER FLUSH) COULD SAVE APPROXIMATELY 38 GALLONS PER DAY OR 14,000 GALLONS PER YEAR. REPLACE YOUR HIGH VOLUME TOILET WITH A HIGH-PERFORMANCE, WATER SAVING MODEL AND SAVE!

WHO QUALIFIES? Applicant must be owner or agent of the residential property where the water/sewer service is provided. This offer does not apply to commercial customers. The installation address must be connected to the Board of Water Supply (BWS) or City & County waste water system.

NEW UPGRADES ONLY. The \$100 rebate is only available for the purchase and installation of a new water-conserving (1.6 gallons or less per flush) toilet that is replacing a high-consumption (3+ gallons per flush) toilet.

The replacement of an **EXISTING 1.6 gpf** toilet with a **NEW 1.6 gpf** toilet does not qualify. Toilets installed in new constructions also do not qualify. Rebate application forms must be received by the BWS within 60 days of the plumbing contractor's invoice date.

SAVE RECEIPTS. Follow the instructions on the back of the rebate application form. Fill out the rebate form carefully. Print your name, address and other information

so it can be easily read. Submit the required receipts and invoices with your rebate application form. Attach a copy of the building permit if the total cost of the project is more than \$1,000.

USE A PLUMBER. State law requires a **PLUMBING CONTRACTOR, LICENSED BY THE STATE OF HAWAII**, to install the toilet and **sign and date the application form**. Homeowners are responsible for selecting, scheduling and paying the plumber. Be sure your plumber sets the water line to the markings on the overflow tube.

If all requirements have been satisfied, the BWS will send a check for \$100 for every toilet replaced. Any toilet for which a rebate is issued is subject to an on-site verification inspection.

ULTRA-LOW FLUSH TOILET REBATE PROGRAM APPLICATION FORM AND PROCEDURES

You are eligible to apply for a \$100 rebate for each ultra-low flush toilet you purchase and have installed if you:

1. are connected to the City's sewer or water system,
2. replace or replaced an existing non ultra-low flush toilet (3+ gallons/flush) with a new ultra-low flush toilet (1.6 gallons or less/flush),
3. have a licensed plumbing contractor perform the installation, and
4. the new ultra-low flush toilet is installed on residential NOT commercial property.

PROCEDURE

1. Complete this application form
2. Attach a sales receipt for the purchase of a qualified ultra-low flush toilet
3. Attach a copy of a licensed plumbing contractor's invoice for installation (must include date)
4. Attach a copy of the building permit if the total cost is over \$1,000
5. **SUBMIT ALL OF THE ABOVE**, within 60 days of the plumbing contractor's invoice date, to:

APPEAL

Anyone whose application has been denied may appeal the decision. Please call 748-5969 for information on the appeal process. Appeals will be considered only when proofs of purchase and installation have been provided.

PENALTIES

There is a penalty of a maximum of \$1,000, imprisonment of up to a maximum of six months, or both if a person files a fraudulent application, makes a false statement, aids or abets the filing of a fraudulent application, conspires with an applicant to defraud the City, or in any manner intentionally deceives or attempts to deceive the City to receive the rebate.
