Board of Water Supply Terms and Conditions

- Rebates: Subject to these Terms and Conditions, Board of Water Supply, City and County of Honolulu ("the Program") will pay rebates for the installation of
- 2) Eligibility:
 - a) An "Applicant" is a Commercial, Multi-Family Residential (MFR), Agriculture, or Irrigation-Only Honolulu Board of Water Supply account holder receiving potable water services from the Board of Water Supply. This program does not apply to new construction projects or Municipal account holders. Rebates are awarded only to eligible Account Holders. The Account Holder may reassign the rebate payment to another Payee in Step 2. Applicants are ultimately responsible for compliance with these Terms and Conditions.
 - "Qualifying Devices" are those water-saving items that are identified in the program materials. For measures listed with ENERGY STAR® or EPA WaterSense® ratings, the brand and model must be LISTED on the ENERGYSTAR.gov or EPA.gov/watersense website. All equipment must be new, meet Program specification requirements, and be fully operable prior to rebate payment:
 - i) Commercial Clothes Washers, Air-Cooled Batch-Type Ice Machines, and Commercial Dishwashers must be ENERGY STAR® certified
 - Rebate amount for Commercial Clothes Washer (Only front and top loader with capacities >1.6 cu ft.): \$75.00 USD
 - Rebate amount for Air-Cooled Batch-Type Ice Machine: \$100.00 USD
 - Rebate amount for Commercial Dishwasher: \$250.00 USD
 - ii) Weather-Based Irrigation Controllers, Soil Moisture Systems, and Urinals must be EPA WaterSense® labeled
 - Rebate amount for Weather-Based Irrigation Controllers (WBIC): \$100.00 USD
 - Rebate amount for Soil Moisture System (Sensor paired with a qualifying WBIC): lower of \$35.00 USD, or pre-tax cost of product
 - Rebate amount for Urinal: \$50.00 USD (Urinals that are not EPA WaterSense® labeled may still qualify for the rebate if designed as waterless.)
 - Additional Rebates: Water Efficient Dipper Wells (flow rate equal to or less than 0.3 gpm), Commercial Rain Barrel or Tote (100 gallons or more), High Efficiency Pre-Rinse Spray Valves (flow rate equal to or less than 1.28 gpm), Submetering (NTEP Certified and NSF/ANSI 61)
 - Rebate amount for Water Efficient Dipper Well: lower of \$150.00 USD, or pre-tax cost of product
 - Rebate amount for Commercial Rain Barrel or Tote: \$150.00 USD
 - Rebate amount for High Efficiency Pre-Rinse Spray Valves: lower of \$50.00 USD, or pre-tax cost of product.
 - Rebate amount for Submetering: \$150.00 USD (Device purchased prior to November 1, 2023, does not qualify for the rebate.)
 - Pre-approval required to ensure materials and scope meet program requirements. Product data sheets must be submitted along with total number of units to be submetered. Submeters must be for multifamily residences that are master metered. This rebate is not intended for other uses such as landscape irrigation submetering. The Program will issue pre-approval in writing for the rebate incentive once all documentation has been reviewed and meets Program requirements. Applicant must be willing to share post installation submeter usage data.
 - Incomplete applications or applications with missing supporting documents will be returned unprocessed. Copy of invoice/receipt must show make, model, cost, and purchase date. Applicant is responsible for making photocopies of all documents for their own records.
 - Rebate application must be received within six (6) months of invoice/sales receipt purchase date.
 - Device with a cost that is less than the rebate amount does not qualify for the rebate. This requirement does not apply to Soil Moisture Systems, Dipper Wells, and Pre-Rinse Spray Valves.
 - Rebate limit is per Applicant. Applicants previously rebated through the Program are not eligible to receive another rebate for the same type of device.
- Installation Verification and Data Collection: 3)
 - The Program may conduct an inspection to verify pre-installation conditions or confirm installation prior to rebate payment, at any time after receipt of applications and up to five (5) years after payment of rebate.
 - The Applicant must provide reasonable access to the facility, the installed equipment, and related documentation and data for verification.
 - The Program may install metering devices on installed equipment for Program data collection, measurement, and verification purposes, with owner's approval. Compliance: Applicant is responsible for abiding by all applicable laws, rules, and regulations and for complying with all federal, state, and local codes.
- Program Availability: Payment of rebates is not guaranteed and is subject to the availability of funds.
