selection and award of a contract for SharePoint Services

Pursuant to Section 103D-102(b)(4), Hawaii Revised Statutes (HRS) and Subchapter 9, Chapter 3-120 of the Hawaii Administrative Rules (HAR), I am recommending that an exemption be granted from the provisions of Chapter 103D, HRS, for selecting a contractor to award a contract for SharePoint Services.

A. Background:

The current contract for SharePoint services will end on February 12. 2021. In FY20, the Document Management Study identified SharePoint to be the Document Management system for Board of Water Supply (BWS). The projects and tasks identified in the study and the transition of the Manao Project Management Information System using SharePoint Online requires SharePoint expertise and support over the next several years.

B. <u>Describe how procurement by competitive means is neither</u> practicable nor advantageous to the Board of Water Supply (BWS)

Project Category 21-22IT for SharePoint Services was advertised in the Fiscal Year 2021 Annual Notice to Providers of Professional Services posted on the BWS Procurement website on April 30, 2020. The initial deadline for statements of qualifications was on June 1, 2020. Only one submittal was received. Subsequently, BWS reached out to Microsoft Corporation who provided contact information for four local and national vendors with SharePoint experience, one of which was the company that had submitted qualifications by the initial deadline. The other three vendors were contacted via email, twice in July and again in early September. To date, no other submittals have been received.

It is highly unlikely that the use of a request for competitive proposals pursuant to §103D-303, HRS, would yield more responses than were received for the BWS posted request for qualifications pursuant to §103D-304, HRS. Additionally, qualifications and experience are the main determining factors in selecting a vendor rather than price. As such, the use of a competitive sealed bid selection process pursuant to §103D-302, HRS, is not practicable.

C. <u>Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable</u>

BWS will engage in direct negotiations with the vendor that has submitted qualifications to define the scope of work and a reasonable cost proposal for the services required.

Accordingly, I recommend your approval to exempt the negotiation and award of a contract for SharePoint Services from the provisions of Chapter 103D, HRS. The application of this exemption will be limited to these facts and circumstances and may not be used as precedence to award any other contracts.
