Aloha mai kākou e nā hoa makamaka mai ka lā hiki a ka lā kau. Welina nui me ke aloha!

Mahalo nui no kēia 'ākoakoa 'ana o kākou no ka pono o ka lāhui, no ka pono o ka 'āina, a no ka pono o ka wai nō ho'i. Eia he 'ōlelo no'eau e kālele ana i ke ko'iko'i o ka wai.

Chair Anthony translated the 2903 'ōlelo no'eau as Wai apu lau ki—water in a ti-leaf cup. When one goes up mauka and needs a cup to dip water from the stream or spring, they only need to fold a ti leaf to form a dipper.

Chair Anthony stated that it is a pleasant reminder that our ancestors had abundant water and that it was all safe to drink

Chair Anthony welcomed everyone to the September 25, 2023, Regular Meeting of the Board of Water Supply (BWS). He stated that the Board of Water Supply is dedicated to providing safe, dependable, and affordable supply of water now and into the future.

DISCUSSION:

Joyce Lin, Civil Engineer IV, Office of the Manager and Chief Engineer, gave the report.

Board Member Bryan Andaya asked if the Navy is using Nakapuna Company as their consultant or if they are responsible for defueling the tanks at the Red Hill Bulk Fuel Storage Facility.

Ms. Joyce Lin replied that the Navy hired Nakapuna Company to collect non-fuel reuse ideas from the community. She explained that the survey consists of two parts: quantitative to gather ideas, which was completed at the end of May, and now qualitative to determine which option would be most beneficial for non-fuel reuse of the Red Hill Bulk Fuel Storage Facility.

Board Member Andaya inquired if the Nakapuna Company requested the BWS's feedback.

Manager Ernest Lau shared that the Nakapuna Company interviewed him and asked what options would be most beneficial for the non-fuel reuse or closure of the Red Hill Bulk Fuel Storage Facility. He also shared that the Nakapuna Company surveys key stakeholders, and the regulators, the Department of Health (DOH), and the Environmental Protection Agency (EPA) will make the final decision.

Board Member Andaya inquired about the timeline of when the results from the survey would be released.

Ms. Lin responded that the Nakapuna Company and the Navy are expected to release the results in a final report identifying the best non-fuel reuse option for the Red Hill Fuel Bulk Fuel Storage by the end of 2023.

Board Member Andaya asked if the discussion will continue after the regulators have made a decision.

Manager Lau replied that the regulators will determine and approve the final Red Hill Bulk Fuel Storage Facility closure plan. Unfortunately, the timeline is still not known. He mentioned that there may be a Closure Plan Supplement Three. Manager Lau explained the tanks are at a higher elevation and approximately three miles inland. Therefore, the Navy will use gravity as the defueling method, allowing the fuel to flow into tanker ships located at Pearl Harbor. He further explained that gravity would not be able to remove all the fuel, which would leave an estimated 100,000 gallons to 400,000 gallons of residual fuel and sludge in the tanks. Manager Lau shared that the Navy accepted the BWS's invitation to present at the October 2023 Board Meeting to give an update.

Chair Anthony inquired if the discussion would be focused on defueling updates.

Manager Lau responded that he hopes that the Joint Task Force would report on the progress of the defueling of Red Hill tanks, the closure of the tanks, and the remediation cleanup of 80 years of releases.

Chair Anthony asked if the BWS and the Navy have discussed the closure and remediation cleanup in meetings.

Manager Lau stated that most recent Navy discussions have focused on defueling. The "round table" discussions with the EPA and the DOH are more in-depth.

Board Member Max Sword asked if there is a possible third Supplement Closure Plan, would it affect the tentative closure date beyond August 2027?

Manager Lau replied that the BWS will not know until the Supplement Plan is submitted. He stated that the BWS continuously reminds the Navy and the Department of Defense (DOD) to remove the fuel as safely and quickly as possible.

Board Max Sword commented that the critical date is January 2024.

Manager Lau responded that in January 2024, most of the fuel at the Red Hill Bulk Fuel Storage should be removed.

Chair Anthony commented that after the Navy defuels the tanks, over a hundred thousand gallons of fuel and sludge will remain in the tanks.

Manager Lau confirmed that Chair Anthony's comment was noted in the Closure Plan. The Navy will drain as much fuel as possible. He reminded everyone to keep the Joint Task Force in our prayers as they begin the defueling and throughout the process.

#### Testimony by Ann Wright for the Honolulu Board of Water Supply for September 25, 2023 meeting

The blistering editorial in today's September 25, 2023, edition of the Star Advertiser "COST TO COMMUNITY--Navy should pay for Red Hill mess" Reveals so much of the trauma that the November 2021 Red Hill fuel spill has caused our community:

"It's time for consequences — for the Navy to pay up for its dereliction that allowed thousands of gallons of fuel in its Red Hill tank storage facility to spew out in 2021, sickening many and compromising Oahu's water resources."

The litany of lies and purposeful destruction of evidence is horrifying coming from members of the Navy and Department of Defense.

Navy officials "recklessly destroyed" text and phone records between two key officials. The official phone of Capt. James "Gordie" Meyer, then-commander of Naval Facilities Engineering Systems Command Hawaii, was "wiped" in spring 2022 and the official phone of Capt. Erik Spitzer, then-commander of Joint Base Pearl Harbor-Hickam, was wiped clean when he retired in June 2022.

As attorney Kristina Baehr stated: "The Navy knows it has to preserve evidence. "After we filed our first (claims) in February of 2022, the Navy knew that it had to preserve evidence, and it also knew who the key players were. ... I'm not going to say it was intentional, but it was absolutely reckless."

The Navy, and those involved, must be held to account for their negligent actions—and the Board of Water Supply must be reimbursed for the damages done to our aquifer and to water rate increases proposed based on the costs to address the damages.

As the Star Advertiser editorial states: "While most members of the Joint Task Force-Red Hill (JTF-RH) charged with defueling were not responsible for past years of Navy neglect at the facility, they will have to deal with today's deep-seated, justifiable distrust of the military.

It's now been shown just how much the military had lied about Red Hill's safety. Year after year, it averred the facility's integrity — and even as recently as mid-2021, was trying mightily to secure state approval to operate Red Hill for another five years.

Unconscionable. But the November 2021 fuel spill, and subsequent 253 repairs to the facility, revealed the deception.

Further, the Pentagon earlier this month certified to Congress that shutdown of Red Hill would not hurt U.S. military readiness — debunking the Navy's excuse for many years in opposing its closure."

And now you, the Honolulu Board of Water Supply (BWS), is having to propose to raise water rates for us Honolulu water consumers, in part due to increased expense from having to drill monitoring and exploratory wells after the Navy's Red Hill fuel spill.

The BWS has had to drill new monitoring wells to gauge how the contamination is moving and new exploratory wells to find new sources of water, both adding costs where none was previously needed, one of the factors for today's proposed higher water bills.

The proposed increases of 8%-10% annually for five years, from 2024 to 2029 should be funded by the Department of Defense, since it was the Navy's negligence that caused the harm to our residents, aquifer and wells.

The Board of Water Supply through the City and County of Honolulu MUST demand that the Department of Defense cover the costs for these new wells, directly or through reallocation of funds to the BWS. These expenses should not be paid by Honolulu water rate payers.

As a retired U.S. Army Colonel with 29 years in the military, I can guarantee you that the modest amount that will cover the costs of DOD negligence in Honolulu can be covered by the mammoth DOD budget with no effect on US national security.

But we will get reimbursement for the costs our community has incurred, only if we demand it.

We implore the Honolulu Board of Water Supply to demand from DOD reimbursement for costs incurred already in dealing with the Red Hill toxic contamination of our water supply and for the water rate increase you are proposing.



#### Department of Defense Asserts Closing Red Hill Will Not Impact Operational Reading

HONOLULU - The Department of Defense (DoD) has notified Congress that military operations in the United States Indo-Pacific theater will not be adversely impacted by the closure of the Red Hill Bulk Fuel Storage Facility. The report was required by Section 331(c) of the James M. Inhote National Defense Authorization Act for Facal Year 2022. The notification serves as a clear and unequivocal statement that closure of the Red Hill RedSig will proceed as planned.

Pentagon Pross Secretary, Brig. Gen. Pat Ryder, stated in a press briefing today, "This notification was in accordance with the FY23 NDA4, which required the Secretary of Defense to notify compressional defense committees prior to the Department beginning the deflueing process." Further, this achievement 'effects the Copartment's orgonic committees and administrative violent for fell bulk Tuel Storage Facility, while upholding our responsibility to



**DISCUSSION:** 

Joseph Cooper, Waterworks Controller, Finance Division, gave the report.

Board Member Sword referred back to the question that he asked during the Permitted Interaction Group (PIG) meeting, how many new farmers start businesses each year?

Ms. Kathleen Elliott-Pahinui, Information Officer, Communications Office, replied that the BWS was working on getting the answer.

Board Member Andaya asked if the report presented was final or if it would be finalized after the meeting discussion. He commented that he was expecting materials to be presented.

Manager Lau asked Corporation Counsel Jessica Wong about the proper process for a PIG report.

Ms. Wong confirmed that usually, the report is presented at one meeting, and a discussion follows in the next Board meeting.

Manager Lau stated that the draft report was circulated to all the Board Members involved in the PIG, and all the materials presented in the community meetings are accessible on the BWS website.

Board Member Kaneshiro inquired if action on the proposed rates would be taken at the next Board meeting.

Manager Lau explained that the draft PIG report summarizes the discussions regarding the proposed rates during the community meetings. He stated that a PIG is not mandatory in the rate schedule proposal process. He explained that at the October Board meeting, the BWS will request the Board's approval to authorize a public hearing on the proposed rate schedule, including a complete presentation. Manager Lau further explained that if the Board approves to have a public hearing, the BWS will publish a public hearing notice up to 30 days before the public hearing in November.

Board Member Sword asked if the draft report could be amended.

Ms. Wong shared that the Office of Information Practices (OIP) guidelines state that the PIG is dissolved after the PIG presents the report to the Board. Therefore, the report can no longer be amended.

Board Member Sword inquired if the Board is voting on the draft PIG report.

Chair Anthony stated that no action would be taken on this item since the report is presented as an item for information.

For clarification, Vice Chair Kapua Sproat reiterated her understanding of the PIG process. The PIG is now dissolved since the report has been presented to the full Board. Although the materials were not attached when the report was presented, the materials are available on the BWS website for the public to view. If the Board authorizes a public hearing, the BWS will share a detailed presentation that includes materials.

Manager Lau agreed.

# Board of Water Supply Permitted Interaction Group on Water Rates

#### Final Report September 15, 2023

At the Monday, June 26, 2023 Board of Water Supply (BWS) Board Meeting, a Permitted Interaction Group was formed to attend the community meetings, listen to testimony and discuss in-depth the proposed upcoming 5-Year Rate Schedule (FY2024-FY2029). The Permitted Interaction Group appointed by the Board was composed of: Board Member Bryan Andaya, Board Member Jonathan Kaneshiro, Board Member Max Sword.

The Permitted Interaction Group held its first meeting on Tuesday, July 11, 2023, where they discussed the overall proposal and reviewed the community outreach meeting schedule. They asked questions of the BWS rates team about the draft to clarify what was being proposed and affirmed, pending community input, their support for the current proposed rates as well as the new agricultural waiver of the Water System Facilities Charge and Meter Charge and kupuna direct install program.

Community Information Meetings were held on the following days and locations:

- Monday, August 14, Benjamin Parker Elementary School, Kaneohe 9 attendees
- Tuesday, August 15, Japanese Cultural Center, Honolulu 3 attendees
- Wednesday, August 16, Kapolei Hale, Kapolei 6 attendees
- Wednesday, August 23, Mililani Highschool, Mililani 3 attendees

Permitted Interaction Group member Jonathan Kaneshiro attended all four community meetings. Permitted Interaction Group member Max Sword attended the Kaneohe meeting.

On Wednesday, September 6, 2023, the Permitted Interaction Group met for the final time to discuss the input from the four Community Information Meetings as well as other meetings the BWS rates team was attending and presenting at. The Permitted Interaction Group stated the following:

- Jonathan Kaneshiro observations regarding the community meetings: The Community
  Information Meetings were informative, lots of good feedback. The rate proposal was well
  received. There were a few questions, and they were answered well. The different increases
  across the tiers were well received. Nobody said the rates were being raised to high.
- Max Sword observation regarding the community meeting he attended: No major negatives. The explanations were really good.

The BWS rates group then reported on the five Neighborhood Board meetings they presented at so far, stating that they have been getting common questions at all of meetings: desalination, Red Hill, tiered rates for non-residential (resorts should pay more), conservation initiatives, and sewer rates. This mirrors the questions heard at the Community Information Meetings. Overall reception by the public of the rate proposal has been positive. While the community is concerned about rates going up (along with

everything else), they understand the reasons behind the proposed increases and support that maintaining the integrity of the water system is critical.

The BWS rates group has another 16 Neighborhood Board meetings to present at through the rest of September and into October. Comments on the proposal are being accepted through October 15 to accommodate the presentation schedule. There are also other meetings the BWS rates group will be at or has attended where they spoke about the rates.

Permitted Interaction Group Member Andaya suggested that the low attendance at the Community Information Meetings may have reflected the impact of the Maui fires; however, it was noted that attendance was similar back in 2018.

The Permitted Interaction Group discussed that the proposed waiver for new farmers has been well received and there has been no pushback. The BWS rates group met with a small stakeholder group that has assisted in drafting the language for the waiver for new farm hookups and they are very supportive. Permitted Interaction Group Member Sword asked how many new farmers per year do we get? Can the BWS rates group provide a projection of what that might look like going forward? The BWS team will provide that information. Sword stated that he was curious about the numbers.

The proposed kupuna direct install program has also been receiving positive feedback and a lot of interest.

The Permitted Interaction Group felt it was important not to delay the roll out of the new rates slated for February 1, 2024, and that the BWS should continue to move forward with that date in mind.



Subject: <u>Status Update of Groundwater Levels at All Index Stations</u>

Eight aquifer index stations were in low groundwater condition for the production month of August 2023. Beretania, Moanalua, Pearl City, Waipahu, Kaluanui, and Waialua are in Caution Status. Kaimuki and Punaluu are in Alert Status. The monthly production average for July 2023 was 148.95 million gallons per day.

The Board of Water Supply rainfall index for the month of August 2023 was 38 percent of normal, with a 5-month moving average of 91 percent. As of September 5, 2023, the Hawaii Drought Monitor shows abnormally dry conditions along the uppermost elevations of the Koolau Range, with moderate drought conditions throughout the rest of Oahu. The National Weather Service is forecasting below-normal precipitation through March 2024.

Most monitoring wells exhibited decreasing head levels for the month of August 2023, likely reflecting the typical increase in summer production combined with the consecutive months of lower-than-average rainfall. Average monthly production for August 2023 was similar to July 2022 and the 5-year monthly average. Increased conservation messaging is recommended for the remainder of 2023, possibly into early 2024.
