SUBJECT: RED HILL TANK COMPLEX, OCTOBER 2013 GROUNDWATER
MONITORING RESULTS FOR OUTSIDE (NON-TUNNEL) WELLS,
FACILITY ID NO. 9-102271, RELEASE ID NO. 99051,

010011, AND 020028

On October 23, 2013, Environmental Science International, Inc. (ESI) collected quarterly groundwater samples from wells HDMW2253-03 and OWDFMW01, as outlined in Commander Navy Region Hawaii letter 5090 Ser N45/4039 of February 18, 2009. Both wells are located outside the Red Hill Fuel Storage Facility.

The Navy is submitting the Fourth Quarter 2013 - Quarterly Groundwater Monitoring Report for Outside Tunnel Wells as Enclosure 1.

The groundwater samples were analyzed for petroleum constituents. Laboratory analytical results indicate all chemical of potential concern (COPC) concentrations were below the DOH Drinking Water Toxicity EALs and the DOH Groundwater Gross Contamination EALs, except for TPH-D. TPH-D was detected at concentrations of 170 and 200 ug/L at OWDFMW01, which were above the DOH EAL for Gross Contamination (100 ug/L) and the DOH EAL for Drinking Water Toxicity (190 ug/L).

Although TPH-d was detected at OWDFMW01 at concentrations above the DOH EALs for both drinking water toxicity and gross contamination, the concentrations decreased from the last four sampling events.

Continued quarterly sampling is recommended for both groundwater monitoring wells. The next sampling event is scheduled for January 2014. The next quarterly groundwater
